## **CALL FOR APPLICATIONS SECOND ROUND**

**DEADLINE: 1 JULY 2017**

This year is the 30<sup>th</sup> anniversary of the enactment of New Zealand's Nuclear Free legislation – the Nuclear-Free Zone, Disarmament, and Arms Control Act 1987. The Act created the Public Advisory Committee on Disarmament and Arms Control (PACDAC), to advise government on the implementation of the Act and on other aspects of disarmament and arms control; to publish reports on the implementation of the Act and on other disarmament and arms control matters; as well as to make recommendations regarding funding for disarmament and peace related activities.

In pursuit of that mandate, PACDAC is hosting a *New Zealand Nuclear Free @ 30 Symposium* to be held in Parliament on the evening of 27<sup>th</sup> July 2017. Discussions will include New Zealand's history and leadership on disarmament issues; progress towards the Nuclear Weapons Ban Treaty; and future opportunities for New Zealand to promote peace and disarmament

Some funding was available to assist people from around New Zealand to attend this Wellington event, and PACDAC determined that in assigning funding, there would be a particular emphasis on encouraging participation by New Zealand youth, as well as recognizing the contribution of civil society . We were delighted to receive applications from all around Aotearoa and have made a number of grants following the first round of applications.

However, we continue to have some funding still available and are therefore releasing this Call for a second round of applications.

All applications for funding to attend should provide the following information:

- Your name and contact details, including email and phone numbers
- If you are applying on behalf of an organisation, how you will determine which members receive any funding that is being made available?
- A budget of your costs – this can cover transport costs to/from Wellington as well as hotel accommodation of one night per person.
- Your application should include informal quotes to confirm your budget (this might be just screen shots of flights and hotel quotes, although we will be requiring formal accounting following the event).
- Any previous funding that you or your organisation have received from PADET or DEUNIF in the past five years (although please note that this funding is separate from and additional to any PADET or DEUNIF grants)

A decision will be made shortly after the 1<sup>st</sup> July to allow travel arrangements to be made in a timely fashion.
